The rest would kill her just for being her mother's daughter-like Xaden Riorson, the most powerful & ruthless wingleader in the Riders Quadrant. She'll need every edge her wits can give her just to see the next sunrise. Yet with every day that passes, the war outside grows deadlier; the kingdom's protective wards are failing; & the death toll continues to rise. Even worse, Violet begins to suspect leadership is hiding a terrible secret.





DANIEL HANDLER, AKA LEMONY SNICKET

Writing as Lemony Snicket, Daniel Handler has led several generations of young readers into that special & curious space of being hopelessly lost, & joyfully finding oneself, in the essential strangeness of literature. The wondrous & perilous journey of the Baudelaire orphans sprung from the author's own path, from his childhood discovery of Baudelaire's poetry through the countless peculiarities of his pursuit of a literary life--abject failure & startling success, breakthrough & breakdown, concordance & controversy--lit along the way by the books & culture he loved best. At once a personal memoir & a literary exploration, a how-to book & a critical inquiry, a sequence of stories & a

TRL is BACK!



Dear Community,


We appreciate the interest in our library efforts & hope you'll allow our perspective to be part of your wider research into deciding how you vote on this measure. We understand the importance of this decision, which is why we invite you to learn about the considerations we've given throughout our efforts to ensure all Venango County residents have direct access to quality public library services. We encourage everyone to make the choice they feel is best for our community. Here, we'll address common themes recognized in recent discussions, including access, relevance, & taxes. Visit oilregionlibraries.org/vote-yes to see how we address specific points, & please suggest any others we can include to give you the most information & context.

Libraries remain an important, vital component of our American identity &, more specifically, throughout our local community. We are committed to providing access, encouraging individual exploration, & promoting community engagement. We stand proudly behind our philosophical stance on providing access & connecting users to information. Information is power, & libraries facilitate power to the people to preserve & enhance our democracy.

Being more practical, consolidating resources saves everyone money by making them available to a wider, shared audience. Libraries consolidate information & resources so that everyone—not just those who can afford it—has the freedom to learn & grow. This allows us to serve a range of needs from basic literacy to career development, individual exploration to formal learning, offsetting individual budgets & providing for those who otherwise wouldn't have access, whether by choice or need. This includes everyone, & that means YOU.

Hundreds of unique users access our resources daily within library walls, online, or at partner community institutions & events. Many of our limitations are capacity-related & not due to lack of use. This effort looks to correct that & guarantee access for our entire public audience.

What have we done to promote access? We voluntarily consolidated 3 libraries under shared governance, combining staffing & resources. Then, we expanded partnerships & fundraising. We include tools, equipment, games, & other resources as part of our required collection purchases. All of this was done to maximize access (to over 200,000 physical resources, 50,000 digital resources, 8 locations, etc.), save costs for our stakeholders, & be more responsive to our community interests.



What are we up against? State law that heavily leans into municipal & school district relationships to determine State Aid eligibility and service standards. Elected municipal leaders haven't realized the incentive-laden components to maintain & enhance their library support. In effect, it has impacted our bottom line, limited our amount of state funding, & threatened direct access to thousands of residents. It also limits our ability to meaningfully respond to demand.

What do we propose? Rather than relying on representative government, we're asking you to decide directly on public library funding. Many use our services, others don't, but still value our role in the community & we continue to explore pathways to reaching those who currently can't or choose not to. Shifting our funds to the county level will qualify us for more state aid, allow everyone to get the same access, & provide us with the means to become more countywide than what we currently are.

So, how relevant are we? Our libraries continue to be heavily utilized. For some, it's periodic use, while others utilize services regularly. We serve through a combination of need & individual choice. We have over 7,500 library borrowers - noting unused accounts are deleted annually, many households share a card, & plenty of services don't require one. Each week, over 500 unique users access their cards & all users combine for over 100,000 physical circulations & 20,000+ digital circulations annually. We offer nearly 500 annual programs, attended by over 6,000 visitors! We were recognized as the Venango Area Chamber Partner in Business (2022) & nominated for an IMLS National Medal for Museum & Library Services (2019). The explosion of the internet in many ways has enhanced our services to allow for more efficiencies, more robust offerings & guides (via resource & staff) to help users access & navigate the digital landscape. This includes 8,000 annual PC sessions, over 28,000 WiFi uses, regular WiFi Hot Spot checkouts, laptop accessibility, & a robust collection of digital offerings (eBooks, language learning, business resources, legal documents, crafts, & more).

What have we done to remain relevant? We voluntarily consolidated services to be more responsive & share a wider reach. We enhanced partnerships to bring our resources to more locations & into community sites such as daycares, elementary classrooms & other service providers. We've opened our spaces to individuals, entrepreneurs & other providers to enhance their own missions. We've expanded resource & service offerings to meet various recreational, educational, & technological interests. We offer physical, digital, on-site & community-based services.

What are we up against? Not everyone gets the same access, so it can confuse the message. Voting YES! will

....change that. Limited budgets & location-specific support create unequal opportunities. People can limit their perception of us as "book lenders" instead of "connectors," which significantly undermines the extent of service offerings we provide. A countywide approach will allow us to develop a bookmobile to broadcast and deliver these resources more widely, plus be more flexible based on actual demand.

And now, taxes.

We do not, nor will we be able to dictate the size of the (tax) pie. That is up to your local elected officials, as it currently stands. In any given budget year, they (school boards, municipalities, county) have the authority to increase, decrease, or keep tax rates the same. This doesn't change that and deserves its own separate discussion. That said, regular election cycles provide voters with the opportunity to voice their opinion on the overall tax rates and decisions made by these officials.

Instead of dictating the size of the pie, we're looking to guarantee that the library has a piece of it (.25 mills, specifically). Once approved, it is up to the discretion of elected officials as to whether this will be added to the current rate, incorporated into existing budgets, or even part of overall tax reductions. Those rates, including the designated library support, may change with any future administration, as they currently can. What this will do is legally codify the minimum library distribution to ensure your ongoing public access through a rare form of direct democracy - giving power to the people to direct specific tax dollars. Then, realize the other portion of our republic through representation. Discussions are already underway to ensure direct representation from County officials on the governing library board so that there is regular oversight and voter accountability.



Some talk about potential tax increases beyond what we're asking, but the reality is that right now, our county and many local governments regularly invest \$0 in public library services. Rather than hypothetical concerns over ballooned budgets, we're focusing on the real, immediate threat to essential services and missing out on additional state support that could be aiding our community. While future administrations could theoretically raise rates above the voter-approved amount, others could also lower it, back to the minimum standard. We're seeking to ensure that the minimum standard is never \$0. Your ongoing voting opportunities will ensure the overall rates remain in line with your expectations.

From our country's founders to state law, access to information and libraries has been a required, clear representation of our society's ideals - for the people, by the people. James Madison argued that knowledge will forever govern ignorance. And the people must arm themselves with the power which knowledge gives. Ben Franklin set the standard by sharing a library collection widely, contributing to our development. Per Thomas Jefferson, "I have often thought that nothing would do more extensive good at small expense than the establishment of a circulating library in every county...", exactly what we seek with this proposal.

Even private benefactors, as made famous by Andrew Carnegie when he paid to build over 2,000 libraries, embraced this sentiment. Realizing private donations weren't enough to guarantee ongoing public access, he donated nothing until the community established dedicated support to sustain the library. Libraries are facilitators, connectors - and practically, huge cost savers - to the people. Our community. Your community. You.

Find Your Rate

Visit the Venango County parcel viewer website (below) & enter your property's address. Click the **Assessment** tab & multiply the Fair Market Value amount by **\$0.00025**. This is the total property tax amount that would be allocated to the library via the referendum.

For example, a property with an assessed value of \$44,540 would have a library property tax amount of \$11.13 per year.

Please note: Assessed Value is different than a Sale Amount.

Our state law would agree. The recognized mutual benefit of ongoing public access to information and connections is heavily rewarded through state funding qualifications and overall levels. Further noting the importance of libraries (unavailable to other service providers, non-profits, etc), a special exception has been made allowing for the approval of dedicated public library support through voter referendum. That has not been a route sought previously in Venango County, mostly due to decades of voluntary government contributions and other support (fundraisers, gifts, state aid, etc.). While no designated tax was on the books, taxpayers had been regularly supporting libraries through their local levels - and in return getting public access.

In recent decades, public funds have voluntarily subsided. Users - by much choice and great need - continue to regularly access and demand our service, but the decision to fund is left to the discretion of select elected officials. Through years of meetings, officials often provided great praise toward our services while voluntarily defunding them, or contributing at levels below the ability to meaningfully serve countywide. As a result, thousands are at risk of losing service in the near future if it remains unchanged.

Your libraries have not stood by idly. We worked to significantly consolidate in order to minimize costs and maximize efficiency for the betterment of public access. Beyond saving costs, we've continued leaning into other ways to raise funds (lessening the overall tax burden) through fundraisers, service fees, grants, & more. Frankly, it's not enough to regularly meet demand. Therefore, we are embarking on the legal path available to us via this referendum. While it may not be perceived as the most fair, it is much more so than the status quo. Everyone will pay the same rate, the funds can be utilized countywide...

...and everyone can share in accessing these vital services.

Many of you already regularly support libraries through your tax dollars. All of you have contributed with your County taxes for 2025. For Oil City residents, this change could mean paying less than you do now while still receiving full services. For communities like Rockland Township, it would be a new investment—but one that finally provides the same direct library access and opportunities that others already enjoy. Prefer to use a different library? That's ok, because supporting one gets you access to ALL of them in PA! Can't make it in? Sign up & utilize your library digitally! Allow us to expand our reach via a bookmobile & more digital offerings.

For all Venango County voters, it will still be a fraction (less than \$15 annually on average) of both the statewide & national rates for public library support. The cost of NOT having access to public library services? You would lose the \$5 in community return on investment for each \$1 currently invested. You would pay significantly more to replicate similar service - or worse, go without it altogether. In total, voting NO would threaten our community's overall quality of life & abandon a founding ideal of providing access to information as a right, not a privilege of the select few.

What do we propose? Every voter gets to weigh in immediately on how their tax dollars are earmarked to support public libraries. The County's direct representation in library governance will allow voters to have a regular voice through future elections. Collecting from the county level allows us to gain NEW qualifications for additional state funds (already budgeted, going elsewhere). Keeping it at affordable rates maintains quality services & allows for countywide expansion. Everyone countywide gets direct access to libraries.

The legal pathway available to us is through property taxes. Other avenues have been voluntarily ignored or underutilized by local officials. Misconceptions about current library funding, state requirements & legal pathways require more than buzzwords and catch phrases to make the point most clear. Significant internal consolidation has reached its limits, combined with funding capacity limits to meet the regular public demand.

VOTE YES - to maintain equitable library services & qualify every resident for a library card. Expand reach. Empower & invest in your community.

VOTE NO - to reduce/eliminate library services, require more residents to pay more for less. Limit reach. Lessen investment in your community & overall quality of life.

TAX: BURDEN OR BOON

How can a tax benefit a community?



WHY NOW?

Local officials decide tax rates each year; libraries cannot. The referendum doesn't raise the overall "pie" of taxes—it simply guarantees libraries a slice. Voters decide directly, & officials retain oversight through representation on the library board.



THE PROBLEM

Many municipalities & the county regularly contribute \$0 to libraries. Funding has declined for decades, leaving thousands at risk of losing access. Praise for library services has continued even as support has been cut.



THE FIX

A dedicated, countywide tax ensures equal support for all residents. Oil City residents may even pay less; townships like Rockland gain full access for the first time. One card = access to all PA libraries + digital services. Average cost: < \$15 per year per resident, far below state & national averages.



THE PAYOFF

Every \$1 invested in libraries returns \$5 to the community. Consolidation, fundraising, & grants have stretched resources as far as possible—this keeps libraries sustainable. Guaranteed funding unlocks new state aid that Venango currently misses.



ROOTED IN HISTORY

This is nothing new. From Ben Franklin & Thomas Jefferson to Andrew Carnegie, libraries have always embodied access to knowledge as a public right. Public funds have always been the primary revenue source of libraries in our country and locally. PA law recognizes this by allowing a rare form of direct democracy for library funding to guarantee ongoing access.



YOUR CHOICE

A YES! vote secures countywide access, new state funding eligibility, & stable services. Ongoing access, by choice or need, in support of education, workforce development, & community connections remain - & likely increase. A NO vote means the loss of library service for thousands, & forfeits millions in community return, lessening overall quality of life.








Inspire Me NEW!


